Evaluation for the work performance shall be done twice a week. Into Legal World will keep update about the developments related to Event, 2018 to the concerned authority of the Institution.



Timeline of Project "Save Prisoners from Injustice"

On 10 March, 2018, Into Legal World decided to fight for the cause of forsaken prisons for injustice done to them. Hence launched a project named "Save Prisoners from Injustice", and launched a campaign of elite law students to write an article for the cause and create awareness. The campaign attracted hundreds of authorities across the nation. Adv. Sanjay Waghmare, Member of Mumbai District Legal Services Authorities, Mr. Bapuji. B, Psychotherapist Counsellor and Criminologist and A Church Pastor, Adv. Arun kumar, who is Ex. Navy Officer Does Councelling in Jail, Mr. Samuel Sandyaraj who is State Conyenor for Legal Matters, are to name a few.

The campaign was started from 19 of March, 2018 and attracted lots of request to continue on the cause.
